In consideration of you granting credit, I/we declare and agree as follows:

- a) The information given is true in all respects.
- b) I/we will promptly advise you in writing of any proposed changes to the business.
- c) The account terms will be Net 30 and all invoices will be paid within 30 days from the invoice date.
- d) I/we will pay any expenses, cost or disbursements incurred by you in recovering any outstanding monies including debt collection agency fees and solicitors costs in addition to our account.
- e) Finance charges may apply for past due invoices at the rate of 2.5% interest per month, dating back to invoice date.
- f) Should any of the following occur:
 - i) Any information provided on this application proves to be incorrect or falsely advised,
 - ii) Any default in payment occurs and/or,
 - iii) I/we enter into bankruptcy/receivership (whether voluntary or otherwise) it is agreed that Allfasteners USA shall retain full right, title and interest to any goods and/or service supplied pursuant to this application.
- g) Governing law and jurisdiction will be determined by Allfasteners and based on the location of sale origination:

 - iii) Sale Origination Nebraska: This Contract shall be governed by the laws of the State of Nebraska, and the venue for any disputes will be exclusively with the appropriate court in Dawson County, Nebraska.
 - iv) Sale Origination Minnesota: This Contract shall be governed by the laws of the State of Minnesota, and the venue for any disputes will be exclusively with the appropriate court in Hennepin County, Minnesota.
 - v) Sale Origination Texas: This Contract shall be governed by the laws of the State of Texas, and the venue for any disputes will be exclusively with the appropriate court in Dallas County, Texas.
